### 3.1 Student Representative Report

# 4. Finance & Property

#### 4.1 Business Manager's Report

Grant Stott gave an update on the Property and Finance Subcommittee meeting of 10 September 2024.

There were three recommendations for the full board to action (separate resolutions):

- 1. To accept the Financial Reports to July 2024
- 2. To accept the 2023 Audited Accounts and Auditor's Report
- 3. To accept the Direct Credit Reports for July and August 2024
- There are no areas of concern with the Financial Reports.
- School donations are sitting at 48% of the parent/caregiver population.
- Three observations and recommendations arose from the Audited Accounts to 31 December 2023. These are school wide observations and recommendations, rather than specifically focused to Long Bay College.

- Mr Healey received the following information from SPANZ regarding the professional coaching and well-being support fund: SPANZ has been made aware of a few examples of 2023 school audit letters including a recommendation that concurrence be sought for this fund. We have contacted the Ministry of Education and the Office of the Auditor General (OAG). This advice was incorrect and the Ministry has clarified with the OAG that concurrence isn't given retrospectively. The other point of note is that this fund is an entitlement under the terms of our collective agreement, hence concurrence is not needed.
- The contract with our canteen provider is up for renewal. The school is currently engaging with four providers (including our current one).
- Watershed has been appointed by the MoE as our independent contractor to develop our next 5 Year Property Agreement.
- The board are invited to the Support Staff Breakfast on Wednesday, 13th November, 8:00am at Bark and Brew in Browns Bay. A calendar invite has been sent. The board secretary will send a reminder to everyone closer to the time.

# 6.4 2025 Trainee Teacher Funding (additional agenda item)

We currently have two candidates in each programme, and Mr Healey suspects we will receive funding for three places. He asked the board if they would be willing to fund an additional trainee teacher at a cost of approximately \$25,000. The board were supportive (separate resolution).
